In addition to a thorough plant health care program, Bartlett Tree Experts recommends having a qualified arborist inspect your property periodically to assist you in identifying potential risks or hazardous conditions relating to your trees or shrubs. Soil Care and Fertilization

Implement Bartlett's Soil Care Program to address soil and nutritional needs of the following landscape plants.

- Sugar Maple located at the far end of playground
- Linden located at the side of playground
- Sugar Maple located at the near end of playground
- Apple located at the near end of playground

This program is custom designed for your landscape based on an inspection of your plants and a soil analysis test. The program will consist of nutrient treatments, pH adjustments, organic components and other soil treatments as needed.

- 1: Spring - Macronutrient treatment - Cost: \$250
- 2: Summer - Fortiphite - Cost: \$250

Tree and Shrub Work

Prune the following property items:

- Sugar Maple located at the far end of playground
- Linden located at the side of playground
- Sugar Maple located at the near end of playground
- Apple located at the near end of playground

according to the following specifications:

- Clean to remove all dead, diseased and broken branches 1" in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
 - Raise canopy of Linden to a height of 8-10' to improve clearance over playground.
- Thin canopies of apple and Linden to improve light and air penetration through canopy

Remove resulting debris.

Amount: \$1,350.00

Take down the storm damaged Bradford Pear located at the side of playground. Leave stump as close to grade as possible. Remove resulting debris.

- Removal of pear tree is recommended due to the unbalanced weight distribution in the canopy, wounds and decay from previous storm damage, and knowledge of species tendency to break under loading from weight of snow and ice.

Amount: \$575.00

Install 1 supplemental support cable in Sugar Maple located at the near end of playground to limit branch movement to reduce the risk of branch failure.

Supports require periodic inspection for evidence of fatigue and to verify functionality. Please contact your Bartlett Arborist to schedule the inspection each year.

Root Invigoration

Root Invigoration™: Cultivate the soil beneath the crown of the following property items:

- Sugar Maple located at the far end of playground
- Linden located at the side of playground
- Sugar Maple located at the near end of playground
- Apple located at the near end of playground

using an Air-Spade to improve soil health and promote root development and function. A radius of approximately 6 feet from the trunk will be cultivated to a depth of 6-8 inches.

Note: The cultivated soil should be irrigated regularly following treatment to keep the soil moist if adequate rainfall does not occur.

- Compost will be added to the soil during cultivation.
- Biochar will be added to the soil during cultivation.


